

The Gym Limited – Additional Terms for 'Me-Set Membership'

Introduction

The following terms apply to the 2 weeks free membership product ('Me-Set Membership') sold between 30th November 2020 to 21st December 2020.

By completing the joining process on our website and becoming a member of The Gym with a 'Me-Set Membership', you are also accepting all the terms and conditions in this document. You should only join if you have read them and accept them.

Where applicable the terms of the Privacy & Cookie Policy prevail in the event of an inconsistency.

Additional Terms

We have set out below the terms and conditions for our Me-Set Membership Promotion.

- 1. The Promoter is The Gym Limited plc of 5th Floor, One Croydon, 12 16 Addiscombe Road, Croydon, CRO 0XT.
- 2. The 'Me-Set Membership' starts on the date that you select when signing up online and works on full calendar days. For example, if you selected to start a membership on 05/12/2020 your membership would start at 00:00 on 05/12/2020.
- 3. Please note that we are closed on both Christmas Day and Boxing Day so please avoid activating your Me-Set Membership on these days. If your 2 free weeks does fall over those 2 days, they will still be included in your Membership despite the gym being closed.
- 4. The 'Me-Set Membership' will finish 2 weeks after the start date selected irrespective of if the gym is closed over that 14-day period. For example, if you selected to start a membership on 05/12/2020 your membership would expire at 23:59 on 18/12/2020.
- 5. You will not be able to change the start or end date of the 'Me-Set Membership' once selected during the sign-up online process.
- 6. 'Me-Set Membership' will apply to the 1 gym you select during the sign-up online process. Once signed up, you cannot change this gym.
- 7. 'Me-Set Membership allows access to The Gym only between the hours of 10am and 4pm, 7 days a week. You must both enter and exit between these hours. If you stay in The Gym outside of these hours, we reserve the right to cancel your membership immediately and without compensation.
- 8. You are only eligible to redeem one 'Me-Set Membership' in 2020. After the 2 weeks free period, you will need to sign up for a monthly membership or a fixed-term membership should you wish to continue receiving access to The Gym.
- 9. The 2 weeks free offer is not transferrable; no cash alternatives will be offered.
- 10. We reserve the right to remove the 'Me-Set' from sale in any gym before the national offer ends on 21st December 2020.



- 11. In the event of a national or regional lockdown the 'Me-Set Membership' will not be frozen unless we communicate otherwise. This means that if the gym you select to visit closes during your 2-week free period, your 'Me-Set Membership' time period will not be extended.
- 12. These terms and conditions shall be governed by and construed in accordance with the law and subject to the exclusive jurisdiction of the courts of England and Wales.
- 13. We reserve the right to make reasonable changes to the Gym Membership Rules and the Membership Agreement at any time. It is your responsibility to check online at regular intervals for changes to these documents.
- 14. We reserve the right to end this promotion at any time. We recommend that you print out a copy of these Additional Terms for your records and future reference.
